Online training

On 27 February 2023, ELF (in collaboration with the Council of Bars and Law Societies of Europe – CCBE) organised a webinar on the impact of climate change on lawyers' practices.

The webinar was divided into sessions dealing with issues such as climate conscious lawyering and recent climate change litigation in Europe. The event was recorded and is available for free on [ELF's website](#). The training material presented during the webinar are freely accessible [here](#).

More than 558 lawyers attended the webinar, which was the first held in 2023 under the operating grant awarded by the European Union to ELF in 2023. The next webinar is expected to take place in June 2023, and to focus on the European Public Prosecutor's Office (EPPO).

TRALIM 3 MANUAL

In 2022, ELF (in collaboration with various EU national and local Bars) launched its third project on training of lawyers on EU immigration and asylum law. The first seminar took place in Nicosia on 20 February, which was followed by a seminar in Dublin on 9 March. More seminars will be held in various Member States in 2023.

In addition, the project has produced a manual on best practices in immigration and asylum cases in the 7 Member States represented by our project partners (Cyprus, France, Greece, Ireland, Italy, Poland and Spain).
