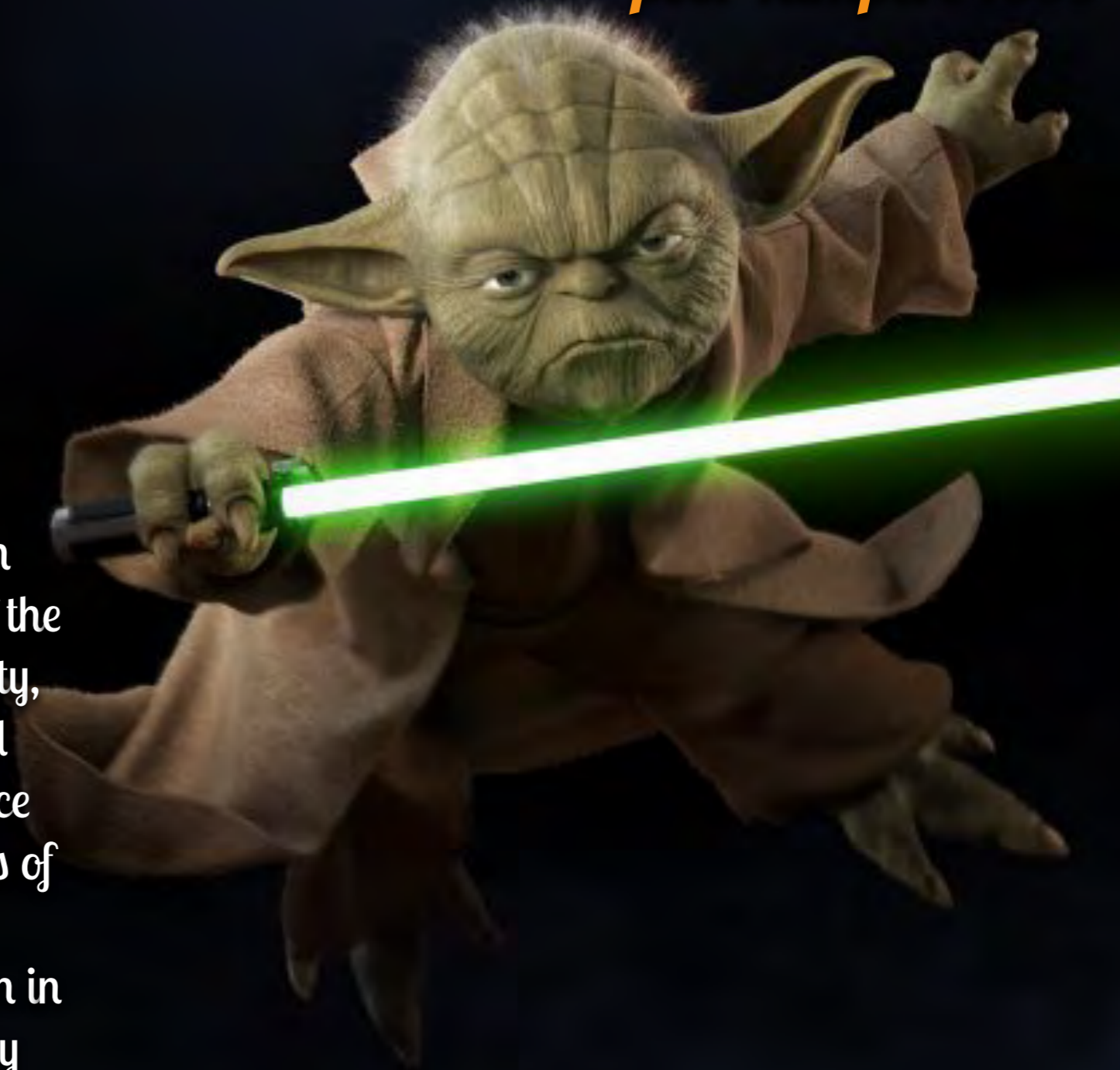

Whereas 83 This Regulation requires the EPPO to respect, in particular, the right to a fair trial, the rights of the defence and the presumption of innocence, as enshrined in Articles 47 and 48 of the Charter. Article 50 of the Charter, which protects the right not to be tried or punished twice in criminal proceedings for the same offence (*ne bis in idem*), ensures that there will be no double jeopardy as a result of the prosecutions brought by the EPPO.

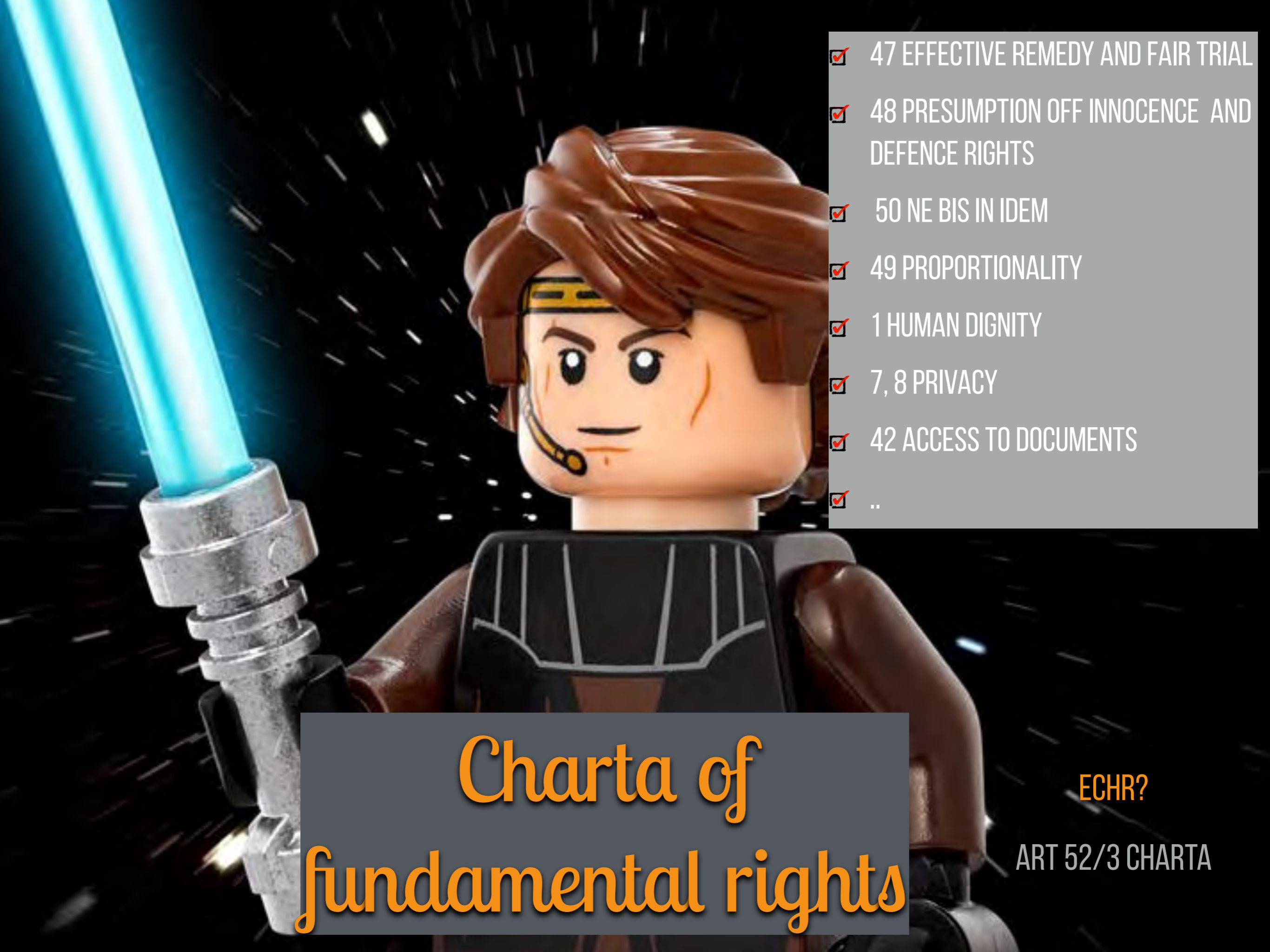
Article 5 The EPPO shall ensure that its activities respect the rights enshrined in the Charter. and shall be bound by the principles of rule of law and proportionality in all its activities.

Article 41 The activities of the EPPO shall be carried out in full compliance with the rights of suspects and accused persons enshrined in the Charter, including the right to a fair trial and the rights of defence. . Any suspected or accused person in the criminal proceedings of the EPPO shall, at a minimum, have the procedural rights provided for in Union (...). 3. Without prejudice to the rights referred to in this Chapter, suspects and accused persons as well as other persons involved in the proceedings of the EPPO shall have all the procedural rights available to them under the applicable national law (...)

ORDER

All matters relating to investigations under the Department, except those to be made by bank examiners, and in connection with the naturalization service, will be referred to the Chief Examiner for a memorandum as to whether any member of the force of special agents under his direction is available for the work to be performed. No authorization of expenditure for special examinations shall be made by any officer of the Department, without first ascertaining whether one of the regular force is available for the service desired, and, in case the service cannot be performed by the regular force of special agents of the Department, the matter will be specially called to the attention of the Attorney General, or Acting Attorney General, together with a statement from the Chief Examiner as to the reasons why a regular employee cannot be assigned to the work, before authorization shall be made for the expenditure of any money for this purpose.

The Federal Bureau of Investigation is collecting racial and ethnic information and “mapping” American communities around the country based on crude stereotypes about which groups commit different types of crimes. Nationwide, the FBI is gathering reports on innocent Americans’ so-called “suspicious activity” and sharing it with unknown numbers of federal, state and local government agencies.
