RESULTS OF THE LAWYEREX 2 PROJECT


LAWYEREX 2 continued the extraordinary results that had been achieved by its predecessors, which led to the establishment of a fully functional and highly regarded exchange scheme for lawyers in Europe.

The main result of the project was that it offered the opportunity to 124 lawyers from 9 different countries to work abroad in host institutions of the legal sector (law firms or Bars), to learn and immerse themselves in other Member States legal systems and to integrate into the working life of their counterparts in other EU countries.

Alongside the excellent ratings (4.85 out of 5 was the average satisfaction rate), participating lawyers and their supervisors stressed the added value of the project in the following regards:

- greater mobility of lawyers in Europe
- increased knowledge of other Member States' legal systems
- consolidation of cross-border networks of lawyers and law firms and
- contribution to the development of a common, European judicial culture.

But the effort cannot stop here. Based on the successful mechanism in place, ELF in partnership with 13 lawyers' organisations presented to the European Commission a continuation project called LAWYEREX 3.
